

# CAMPGROUND REGULATIONS

WELCOME TO THE WEEPING WATER CITY LAKES  
SO THAT EVERYONE CAN ENJOY THEIR STAY WITH US  
PLEASE ADHERE TO THE FOLLOWING REGULATIONS  
AS SET FORTH BY THE  
THE CITY OF WEEPING WATER

## IT'S UNLAWFUL TO. . . . .

### Abandoned Property

- Leave any vehicle or other personal property unattended for more than 24 hours without permission of the camp host.

### Audio Devices

- Operate or use any audio device (such as a radio) in a manner or at a time that is unreasonably annoying or a danger to persons in public places.
- Operate or use a public address system without permission from the City of Weeping Water.

### Camping

- Park camping units in campgrounds other than designated campsites.
- Dig or level ground in campsites without permission of the camp host.
- Leave any personal property when departing an area or site, including litter.
- Hook fresh water hoses to hydrants continuously. All fresh water hoses must be disconnected from hydrants after each use. All hoses are to be stored either in or under campers to allow for routine mowing and maintenance work.
- Use generators (unless an emergency situation arises).

### Destruction of Property

- Possess, destroy, injure, deface, remove or disturb any building, sign, equipment or other structure, or any plant or animal matter, including flowers, nests, mineral formations, artifacts or relics, or other public property without the permission of the camp host.
- Destroy, dig, remove, or possess any tree, shrub, or plant, except for dead wood found on the ground and used for fuel.

### Fire and Fireworks

- Build any fire outside of the provided fireplaces. Stoves, lanterns, or grills are permitted.
- Leave a fire unattended.
- Use or possess fireworks or explosives.

### Vehicle Operation

- Exceed the posted speed limit.
- Operate a vehicle anywhere other than designated roads, trails, parking areas or campgrounds.
- Operate any unlicensed motor vehicle, including minibikes, three- and four-wheeled ATVs, golf carts, and dune buggies.

### Sanitation

- Drain or dump RV/trailer wastes anywhere other than the receptacles provided.
- Clean food, fish, or fowl, or wash clothing or other personal property at area hydrants.
- Dispose of body wastes except in receptacles provided for that purpose.
- Dump household or commercial refuse brought from private property.

### Swimming

- Swim in city lakes.

- Use flotation devices that are not U.S. Coast Guard approved.
- SCUBA dive in city lakes.

### **Meetings**

- Conduct a public meeting, assembly, religious service or special event except by permission from City Clerk.

### **Miscellaneous**

- Sell any goods or services without a permit.
- Sell or distribute any printed matter without a permit.
- Install any permanent or semi-permanent structure without a permit.
- Use roller skates or skateboards other than in designated locations.
- Discharge firearms.
- Operate gasoline powered craft on the city lakes.

## **OTHER REMINDERS. . . .**

- Camp fees must be paid at time of arrival at park entrance
- **All camping pads will be considered open if there is no camper on them**
- All campers must be parked on camper pad.
- One camper per pad.
- Camp Fees: Electrical-\$15.00 per night; Non-Electrical(tents)-\$7.00 per night
- One tent for immediate family allowed with camper. Each additional tent will be charged \$7 per night.
- If it is licensed, it is considered a camper.
- Pull-type campers must be backed onto pads.
- Check-out time is 3PM. Additional night charge will be added if still parked in campsite after this time.
- Quiet hours in campgrounds are in effect from 10 PM to 6AM.
- Speed limit is 10 MPH in the park.
- Dump station for paying campers only.
- Showers are for paying campers only.
- All animals must be on a leash no longer than 6 feet, crated or caged, except for Seeing Eye or other service dogs. Public buildings are off-limits to all animals except Seeing Eye and service dogs. Please Clean Up After Pets.
- Littering is not only an offense, it is offensive. Please dispose of all refuse properly. Help keep our park clean and green.
- All garbage should be placed in the dumpster at the west end of the campground
- Violation of regulations governing City Lake rules will be considered a misdemeanor and, upon conviction, could result in a fine of not more than \$100.
- **Campers must be relocated to another campsite following occupation of 21 days to allow for adequate park maintenance.**
